### APG Calls on Congress to Fund the U.S. National Archives

The Advocacy Committee's Alec Ferretti highlights how members can get involved with the campaign to save a vital national resource



The National Archives and Records Administration (NARA) is the cornerstone of government transparency, historical preservation, and public access to records.

From genealogists tracing family histories to veterans seeking service records, from journalists investigating government accountability to everyday citizens looking for historical documents,

NARA provides invaluable services to the American public, and is a fundamental institution required for genealogists to run their businesses.

Yet, despite its critical role, NARA has suffered from decades of underfunding, severely limiting its ability to fulfill its mission. The agency is struggling to preserve fragile historical materials, process record requests in a timely manner, and digitize millions of documents to ensure accessibility for future generations. Without urgent intervention, access to public records—records that belong to the people—will continue to deteriorate. APG fears that Congress may attempt to cut NARA's budget in the incoming year, at a time when they can already barely keep the lights on.

NARA's budget has remained stagnant for years, even as the volume of federal records has expanded exponentially. Millions of cubic feet of historic records remain with other agencies, waiting for the day NARA has the bandwidth to properly accession them. Today, only 3% of the agency's textual records have been digitized. The agency faces years-long backlogs in screening records that require FOIA review, and the onslaught of records will only get worse every year.

Additionally, ongoing staffing shortages and outdated infrastructure mean that crucial records remain in peril, vulnerable to deterioration or even permanent loss. Without substantial funding increases, NARA cannot meet the demands of a modern digital age, nor can it keep up with records management responsibilities for federal agencies. Without proper funding, the backlog of record requests will worsen, access to government documents will be delayed, and vital historical records may be lost forever.

APG advocates for Congress to maintain funding levels for NARA at US \$427.3 million. This is necessary to:

- Expand digitization efforts to make records available online
- Hire additional staff to reduce processing backlogs
- Improve infrastructure to better preserve fragile historical materials
- Modernize records management systems to keep up with growing demand

#### **How You Can Help**

We need your voice to make a difference. Here's what you can do:

#### **Engage with FundNARA:**

Stay updated on advocacy efforts by following FundNARA (https://fundnara.com), a volunteer, non-partisan project coordinated by an ad hoc group of genealogists, historians, and records access advocates.

**Contact Congress:** (if you are a US resident)
Tell your representatives that full funding for NARA is essential. Ask them to support the proposed \$427.3 million budget. FundNARA has comment starters and links to aid in reaching out to your elected officials.

**Spread Awareness:** (no matter where you are) Share this website with fellow genealogists, and encourage them to advocate for proper funding to their own legislators.

The records held by NARA belong to all of us. They tell the story of America and ensure transparency in government. We cannot allow decades of underfunding to continue jeopardizing our access to these vital materials.

Your voice matters. Let's work together to ensure that NARA receives the funding it needs to preserve our shared history for generations to come.

#### Strathclyde Institute for Genealogical Studies launches new "Papal Dispensations for Marriage" database

The Glasgow based Strathclyde Institute for Genealogical Studies

(https://www.strath.ac.uk/studywithus/centreforlifelonglearning/genealogy/) has developed an online database of papal dispensations for marriage, intended for use in genealogical investigation.

Until recently, the papal dispensations granted for marriages in Britain and Ireland between those related within the prohibited degrees and covering the period 1198 to 1534 were not available in a single place online.

The 'Papal Dispensations for Marriage Project' funded by the Foundation for Medieval Genealogy, has been focusing on creating a database that will initially cover volumes 1 to 20 and volume 23 part 1, by extracting entries relating to marriage – specifically papal dispensations for marriage – from the published calendars of papal registers/letters in a consistent format, to develop a searchable online database.

The aim of the project is the ongoing development of an easily accessible online relational database that will be useful for academic and genealogical research by medieval historians and medieval genealogical researchers.




#### **APG Hires New IT Administrator and Social Media Specialist Contractors**

#### **Look Ahead to 2025 Opportunities for Continuing Education Hours**

Some suggestions for the present year from Jenifer Kahn Bakkala, chair of the Continuing Education Committee



APG members were actively involved in a wide variety of Continuing Education endeavors last year, according to 2024 submissions of APG's CE Reporting form.

Reporting for 2024, which took place in January, showed that members engaged in numerous hours of genealogical and business education in the form of college courses, institutes, conferences, discussion groups, lectures, webinars, and online courses.

In addition, one of the largest categories was self-directed study, whereby members moved their careers forward through dedicated reading, listening to podcasts, mentoring, being mentored, preparing teaching materials, and learning new aspects of their field.

As 2025 is already under way, now is the time to think about educational opportunities for the coming year, and how to keep track of them as part of your professional routine. A few things to keep in mind:

- Education can take a wide variety of formats. Courses, institutes, and webinars are not the only
  experiences that count. Consider self-directed study in the year ahead: a mentoring relationship,
  dedicated reading, learning a new skill.
- Not all education needs to be "genealogical." Learning how to keep better business records, finding out about new tax laws in your area, or taking a class on marketing your business, are all acceptable forms of education to report. If you work as a librarian, a publisher, or in another related career, education in those areas is eligible to submit for the requirement.
- Keeping track makes reporting easy. A spreadsheet or a simple list can help you remember your educational experiences in 2025 so that reporting will only take a few minutes in January 2026.

Education is one of the tenets of APG's mission statement, its Code of Ethics and Professional Practices, and its definition of a Professional Genealogist. The CE requirement encourages further career development for our members and strengthens the integrity of our organization to the public.

Annual reporting of at least 12 hours of Continuing Education is required for APG members to remain in good standing. Honorary Lifetime Members and retired members have an exempt status. New members are exempt from the reporting requirement only during their first year of membership.

#### **Congratulations to Luis Ariel Rivera**



Your presentation is what you say. Your slides illustrate and emphasize your points. Creative visuals keep your audience engaged so they can learn from you. Genealogists who teach often have a PowerPoint presentation to accompany their lecture. Many times, these slide presentations are a plain white background with lists of bullet points, or worse, full sentences read by the presenter to the audience. Such lectures become tedious, and attendees tune out. Thoughtfully designed slides illustrate and emphasize the key points of a lecture and keep the audience engaged. A presenter who teaches effectively will be invited back. You put a lot of work into preparing your lecture – what you will say. Your PowerPoint slides are there to illustrate and emphasize your words.

#### Writers SIG



The APG Writers SIG continued its stellar lineup of speakers with Mark Lowe speaking on 19 February on the topic of "Sharpening Our Digital Skills for Genealogical Writing and Presentations."

Our next meeting is on 19 March 2025 when John Colletta, Ph.D. will speak on "More Than Pretty Pictures: Sources for Visual Enhancement of Your Story."

In his words: "Using three articles of mine that have been published in the past four and a half years, as well as Only a Few Bones, I talk about the illustrative images—photographs, prints and engravings, documents, maps, etc. —and discuss why I selected them and not other possibilities (including a couple that the editor rejected). I propose some "Bedrock Principles" and some "Stern Caveats" for illustrative material that accompanies historical narrative."

For 40 years John Colletta has helped family historians discover and write the stories of their ancestors. After working at the Library of Congress and teaching classes at the Smithsonian Institution and National Archives, he became a popular lecturer at NGS and FGS national conferences and a faculty member of the Institute of Genealogy and Historical Research (U. of Georgia) and Salt Lake Institute of Genealogy. His publications include many articles, both scholarly and popular, two manuals (*Finding Italian Roots* and *They Came in Ships*), a murder mystery/family history, *Only a Few Bones* (the second edition includes instruction on how to write narrative family history), and a Great Course titled "Discovering Your Roots" available from The Teaching Company. Recipient of professional awards and honors, Dr. Colletta resides in Washington, D.C., where he earned his doctorate at the Catholic University of America.

Michael S. Ramage, JD, CG, is a full-time professional genealogist, author and lecturer. Michael has served as a trustee, officer and currently general counsel of the Board for the Certification of Genealogists, and he was the 2020-2022 president of the APG Forensic Genealogy Special Interest Group. His 25-year law practice included real estate and estate law and litigation. He has taught numerous genealogy courses at genealogy conferences and institutes around the country. His related publications include: (1) Michael S. Ramage, J.D., CG and Catherine B. W. Desmarais, CG, Forensic Genealogy: Theory and Practice (National Genealogical Society, Falls Church, VA: 2025); and (2) the "Forensic Specialization" and "Ethical Considerations" chapters in Professional Genealogy: Preparation, Practice & Standards, Elizabeth Shown Mills, editor (Baltimore, Maryland: Genealogical Publishing Company, 2018).

Ethical rules and guidance are arguably more important to forensic genealogists than others in the industry, given the relationship to the law and living people. This presentation initially provides some background and history of ethics in general, and then specifically as it relates to forensic genealogy.

Examples of commonly encountered ethical landmines in this field will be explored along with the applicable ethical codes adopted by APG, BCG, CAFG and ICAPGen.
